No EN safety standard available

As no safety standard includes tungsten carbide grit cut-off wheels, Bosch engineering is doing the release and serial delivery qualification as close as possible according to EN 13236 with reference to laser melting diamond cut-off wheel (same bore hole size, same min. core blade thickness, allowed production method, material and hardness requirements of core blade fulfilled).

Bosch engineering does the same safety test (spin test) described in EN 13236. Additionally performance and lifetime tests are done for the release to verify the safety in practical application.

The X-LOCK bore hole I also covered in an analog way by the scope of the EN 13236.
